## **CONSENT AGREEMENT**

This Agreement, dated this 35 day of March, 2005, is between the State Board of Veterinary Medical Examiners ("Board") and Kim Hammond, D.V.M. ("Dr. Hammond"), the owner of Falls Road Animal Hospital, Hospital License No. 03-012. The Agreement concerns the charge that the Board filed against Dr. Hammond alleging that he operated a veterinary hospital for a period of time when it did not have a valid hospital license.

# STATEMENT OF FACTS

Dr. Hammond, by entering into and signing this document acknowledges that the Board, by a preponderance of the evidence, could prove the following Findings of Fact:

- 1. For the 2004-5 licensing period, Dr. Hammond has owned and operated a veterinary hospital known as the Falls Road Animal Hospital, located at 6314 Falls Road, Baltimore, Maryland.
- 2. Dr. Hammond was required to renew the license for this hospital facility on or before July 1, 2004, if it was to continue operating as a properly licensed veterinary hospital for

the 2004-5 licensing period. Dr. Hammond, however, failed to renew the license for this hospital facility in a timely manner, and continued to operate it as a veterinary hospital from July 1, 2004 to December 14, 2004 without a valid veterinary hospital license.

3. On or about December 15, 2004, Beverly Raymond, a Board inspector, inspected the Falls Road Animal Hospital, and advised a member of Dr. Hammond's staff that the hospital's license had not been renewed for the 2004-5 licensing period. Thereupon, Dr. Hammond immediately took steps to renew the license for this facility.

# **CONCLUSION OF LAW**

From July 1, 2004 to December 14, 2004, Dr. Hammond owned and operated a veterinary hospital known as the Falls Road Animal Hospital, located at 6314 Falls Road, Baltimore, Maryland, but the facility did not have a valid hospital license, and in so doing, violated Agriculture Article, §2-304.1, Annotated Code of Maryland, and COMAR 15.14.03.01-1.

#### **ORDER**

Based on the foregoing Findings of Fact and Conclusions of Law, finding that Dr. Hammond violated Agriculture Article, §2-304.1, Annotated Code of Maryland, and COMAR 15.14.03.01-1, it is this 25 day of Maryland, 2005, by the State Board of Veterinary Medical Examiners, **ORDERED** that Dr. Hammond pay a civil penalty in the amount of Three Hundred Dollars (\$300.00). The Board acknowledges that Dr. Hammond as already paid this penalty.
