CONSENT AGREEMENT

This Agreement, dated this day of November, 2006, is between the State Board of Veterinary Medical Examiners ("Board") and Adrienne A. Edwards, D.V.M., License No. 2894 ("Dr. Edwards"). The Agreement concerns the charges that the Board filed against Dr. Edwards, alleging that she violated the Maryland Veterinary Practice Act (Md. Code Ann., Agric Art. §§2-301, et seq.), by operating a veterinary hospital for a period of time without renewing its license.

Under the Veterinary Practice Act, the Board "may refuse, suspend, or revoke any application or license, and censure or place on probation any licensee ... if the veterinarian ... [f]ails to comply with Board ... regulations after receiving a license" (Md. Code Ann., Agric. Art., §2-310(8)); and in lieu of, or in addition to, suspending a veterinarian's license, the Board may impose a civil penalty of not more than \$5,000 (Md. Code Ann., Agric. Art., §2-310.1).

FINDINGS OF FACT

Dr. Edwards, by entering into and signing this document, acknowledges that the Board could produce evidence establishing the following Findings of Fact:

- 1. At all times relevant to the charges, Dr. Edwards was, and is, licensed to practice veterinary medicine in the State of Maryland; and owned and operated the Pet Depot Pet Care Clinic, located at 8337 Grubb Road, Silver Spring, Maryland.
- 2. From July 1, 2005 to June 21, 2006 (to wit: the Fiscal Year 2005-06 Licensing

period), Dr. Edwards operated the above-referenced facility as a veterinary hospital. Dr. Edwards, however, did not have a license from the Board to operate this facility as a veterinary hospital for this time period.

CONCLUSIONS OF LAW

Based upon these Findings of Fact, the Board makes the following Conclusions of Law: From July 1, 2005 to June 21, 2006 (to wit: the Fiscal Year 2005-06 Licensing period), Dr. Edwards owned and operated a veterinary hospital known as Pet Depot Pet Care Clinic, located at 8337 Grubb Road, Silver Spring, Maryland, without a valid hospital license from the Board, and in so doing, violated Agriculture Article, §2-304.1, Annotated Code of Maryland.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, finding that Adrienne A. Edwards, D.V.M., License No. 2894, violated Agriculture Article, §2-304.1, Annotated Code of Maryland, it is this Logarity day of Movember, 2006, by the State Board of Veterinary Medical Examiners, **ORDERED**: That Dr. Edwards pay a civil penalty in the amount of Two Hundred Fifty Dollars (\$250.00) (the Board acknowledges Dr. Edward's payment of this penalty).
