CONSENT AGREEMENT

This Consent Agreement, dated this U day of December, 2006, is between the State Board of Veterinary Medical Examiners (ABoard®) and Kenneth E. Fox, D.V.M., License No. 4835 (ADr. Fox®), the owner of Glymont Animal Hospital, Hospital License No. 08-002. The Agreement concerns the charges that the Board filed against Dr. Fox alleging that he owned and operated a veterinary hospital known as Glymont Animal Hospital from December 1, 2005 to February 23, 2006, without a valid hospital license.

Under State law, the Board is the licensing authority responsible for regulating the practice of veterinary medicine in this State, which includes filing disciplinary actions against veterinarians charged with violating the provisions of the Veterinary Practice Act and regulations adopted thereunder. The Board "may refuse, suspend, or revoke any application or license, and censure or place on probation any licensee ... if the veterinarian ... [f]ails to comply with [the Veterinary Practice Act and] Board rules and regulations after receiving a license" (Md. Code Ann., Agric. Art., '2-310(8)); and in lieu of, or in addition to, suspending a veterinarian's license, the Board may impose a civil penalty of not more than \$5,000 (Md. Code Ann., Agric. Art., '2-310.1).

FINDINGS OF FACTS

Dr. Fox, by entering into and signing this document, acknowledges that the Board could produce evidence establishing the following Findings of Fact:

- 1. At all times relevant to the charges, Dr. Fox was, and is, licensed to practice veterinary medicine in the State of Maryland; and owns and operates a veterinary hospital known as Glymont Animal Hospital, located at 4618 Indian Head Highway, Indian Head, Maryland, 20640.
- 2. From December 1, 2005 to February 23, 2006 (to wit: the Fiscal Year 2005-6 Licensing period), Dr. Fox operated the above-referenced facility as a veterinary hospital. Dr. Fox, however, did not have a license from the Board to operate this facility as a veterinary hospital for this time period.
- 3. Subsequently, on February 24, 2006, Dr. Fox did obtain a license from the Board to operate this facility as a veterinary hospital.

CONCLUSIONS OF LAW

Based upon these Findings of Fact, the Board makes the following Conclusion of Law: From December 1, 2005 to February 23, 2006, (to wit: the Fiscal Year 2005-6 Licensing period), Dr. Fox owned and operated a veterinary hospital known as Glymont Animal Hospital, located at 4618 Indian Head Highway, Indian Head, Maryland, without a valid hospital license from the Board, and in so doing, violated Agriculture Article, '2-304.1, Annotated Code of Maryland.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, finding that Dr. Fox violated the Veterinary Practice Act, it is this IL The day of December, 2006, by the State Board of Veterinary Medical Examiners, ORDERED:

That Dr. Fox is assessed a Civil Penalty in the amount of Two Hundred Fifty Dollars and that he pay this penalty to the Board within thirty (30) days from the date of this Consent Agreement.
