CONSENT AGREEMENT

This Consent Agreement, dated this <u>f</u> day of <u>December</u>, 2006, is between the State Board of Veterinary Medical Examiners ("Board") and Robert J. Wesley, D.V.M., ("Dr. Wesley"), License No. 5884. The Agreement concerns the charges that the Board filed against Dr. Wesley alleging that he practiced veterinary medicine in this State during a time period that he was not registered as a licensed veterinarian in this State, a violation of Agriculture Article, §2-313, Annotated Code of Maryland.

Under State law, the Board is the licensing authority responsible for regulating the practice of veterinary medicine in this State, which includes filing disciplinary actions against veterinarians charged with violating the provisions of the Veterinary Practice Act and regulations adopted thereunder. The Board "may refuse, suspend, or revoke any application or license, and censure or place on probation any licensee ... if the veterinarian ... [f]ails to comply with [the Veterinary Practice Act and] Board rules and regulations after receiving a license" (Md. Code Ann., Agric. Art., §2-310(8)); and in lieu of, or in addition to, suspending a veterinarian's license, the Board may impose a civil penalty of not more than \$5,000 (Md. Code Ann., Agric. Art., §2-310.1).

FINDINGS OF FACTS

Dr. Wesley, by entering into and signing this document, acknowledges that the Board could produce evidence establishing the following Findings of Fact:

1. On or about July 1, 2006 through October 25, 2006 of the 2006-7 Licensing Year (July 1, 2006 through June 30, 2007), Dr. Wesley practiced veterinary medicine at the

Peachtree Veterinary Clinic located at 18620 Darnestown Road, Beallsville, MD 20839. During this time period, however, Dr. Wesley was not registered to practice as a licensed veterinarian in this State.

- 2. On June 30, 2006, Dr. Wesley's registration for the 2006-7 Licensing Year expired. He failed to take steps on or before that date to renew it.
- 3. On or about October 25, 2006, Ms. Robin Roscher, an Inspector with the Board, obtained medical records from Peachtree Veterinary Clinic, showing that Dr. Wesley treated animals at this facility during the period that his registration had lapsed (July 1, 2006 through October 25, 2006).
- 4. Dr. Wesley has since taken steps to renew his registration for the 2006-7 Licensing Year.

CONCLUSIONS OF LAW

Based upon these Findings of Fact, the Board makes the following Conclusion of Law: On or about July 1, 2006 through October 25, 2006, Dr. Wesley practiced veterinary medicine at the Peachtree Veterinary Clinic located at 18620 Darnestown Road, Beallsville, MD 20839, but, during this time period, was not registered as a licensed veterinarian in this State, a violation of Agriculture Article, §2-313, Annotated Code of Maryland.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, finding that Dr. Wesley violated the Veterinary Practice Act, it is this day of locenthe, 2006, by the State Board of Veterinary Medical Examiners, **ORDERED**:

That Dr. Wesley is assessed a Civil Penalty in the amount of Two Hundred and Fifty Dollars (\$250.00) and that he pay this penalty to the Board within thirty (30) days from the date of this Consent Agreement.
