## **CONSENT AGREEMENT**

This Consent Agreement, dated this day of Harch, 2007, is between the State Board of Veterinary Medical Examiners ("Board") and Margaret M. Hoffecker, D.V.M., License No. 2634. The Agreement concerns the charges that the Board filed against Dr. Hoffecker alleging that she practiced veterinary medicine in this State during a time period that she was not registered as a licensed veterinarian in this State, a violation of Agriculture Article, §2-313, Annotated Code of Maryland.

Under State law, the Board is the licensing authority responsible for regulating the practice of veterinary medicine in this State, which includes filing disciplinary actions against veterinarians charged with violating the provisions of the Veterinary Practice Act and regulations adopted thereunder. The Board "may refuse, suspend, or revoke any application or license, and censure or place on probation any licensee ... if the veterinarian ... [f]ails to comply with [the Veterinary Practice Act and] Board rules and regulations after receiving a license" (Md. Code Ann., Agric. Art., §2-310(8)); and in lieu of, or in addition to, suspending a veterinarian's license, the Board may impose a civil penalty of not more than \$5,000 (Md. Code Ann., Agric. Art., §2-310.1).

## **FINDINGS OF FACTS**

Dr. Hoffecker, by entering into and signing this document, acknowledges that the Board could produce evidence establishing the following Findings of Fact:

1. On or about July 1, 2006 through October 3, 2006 of the 2006-7 Licensing Year (July 1, 2006 through June 30, 2007), Dr. Hoffecker practiced veterinary medicine at Shawsville Veterinary Hospital, located at 4534 Norrisville Road, White Hall, MD 21161.

During this time period, however, Dr. Hoffecker was not registered to practice as a licensed veterinarian in this State.

- 2. On June 30, 2006, Dr. Hoffecker's registration for the 2006-7 Licensing Year expired. She failed to take steps on or before that date to renew it.
- 3. On or about January 5, 2007, Ms. Beverly Raymond, an Inspector with the Board, obtained medical records from Shawsville Veterinary Hospital, showing that Dr. Hoffecker treated animals at this facility during the period that her registration had lapsed (July 1, 2006 through October 3, 2006).
- 4. Dr. Hoffecker is currently registered for the 2006-7 Licensing Year.

#### **CONCLUSION OF LAW**

On or about July 1, 2006 through October 3, 2006, Dr. Hoffecker practiced veterinary medicine at Shawsville Veterinary Hospital, located at 4534 Norrisville Road, White Hall, MD 21161, but during this time period, was not registered to practice veterinary medicine in this State, a violation of Agriculture Article, §2-313, Annotated Code of Maryland, and COMAR 15.14.01.11.

### <u>ORDER</u>

Based on the foregoing Findings of Fact and Conclusions of Law, finding that Dr. Hoffecker violated COMAR 15.14.01.11, it is this day of Harch, 2007, by the State Board of Veterinary Medical Examiners, **ORDERED**: That Dr. Hoffecker is assessed a Civil Penalty in the amount of Two Hundred Dollars (\$200.00) and that she pay this penalty to the Board within thirty (30) days from the date of this Consent Agreement.
