CONSENT AGREEMENT

This Consent Agreement, dated this 13 day of March, 2007, is between the State Board of Veterinary Medical Examiners ("Board") and Mary M. Reid, D.V.M., License No. 3000. This Agreement concerns the charges that the Board filed against Dr. Reid alleging that she practiced veterinary medicine in this State during a time period that she was not registered as a licensed veterinarian in this State, a violation of Agriculture Article, §2-313, Annotated Code of Maryland.

Under State law, the Board is the licensing authority responsible for regulating the practice of veterinary medicine in this State, which includes filing disciplinary actions against veterinarians charged with violating the provisions of the Veterinary Practice Act and regulations adopted thereunder. The Board "may refuse, suspend, or revoke any application or license, and censure or place on probation any licensee ... if the veterinarian ... [f]ails to comply with [the Veterinary Practice Act and] Board rules and regulations after receiving a license" (Md. Code Ann., Agric. Art., §2-310(8)); and in lieu of, or in addition to, suspending a veterinarian's license, the Board may impose a civil penalty of not more than \$5,000 (Md. Code Ann., Agric. Art., §2-310.1).

FINDINGS OF FACTS

Dr. Reid, by entering into and signing this document, acknowledges that the Board could produce evidence establishing the following Findings of Fact:

1. On or about July 1, 2006 through November 29, 2006 of the 2006-7 Licensing Year (July 1, 2006 through June 30, 2007), Dr. Reid practiced veterinary medicine at Hampstead Veterinary Care, located at 695 Hanover Road, Hampstead, MD 21074.

During this time period, however, Dr. Reid was not registered to practice as a licensed veterinarian in this State.

2. On June 30, 2006, Dr. Reid's registration for the 2006-7 Licensing Year expired. She failed to take steps on or before that date to renew it.
3. On or about January 26, 2007, Ms. Beverly Raymond, an Inspector with the Board, obtained medical records from Hampstead Veterinary Care, showing that Dr. Reid treated animals at this facility during the period that her registration had lapsed (July 1, 2006 through November 29, 2006).
4. Dr. Reid is currently registered for the 2006-7 Licensing Year.

CONCLUSION OF LAW

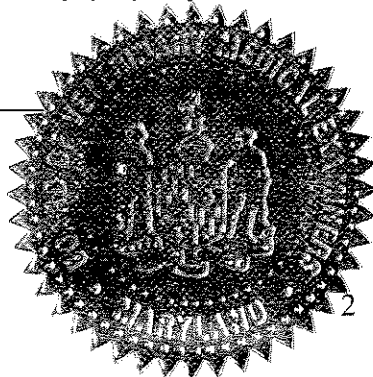
On or about July 1, 2006 through November 29, 2006, Dr. Reid practiced veterinary medicine at Hampstead Veterinary Care, located at 695 Hanover Road, Hampstead, MD 21074, but during this time period, was not registered as a licensed veterinarian in this State, a violation of Agriculture Article, §2-313, Annotated Code of Maryland, and COMAR 15.14.01.11.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, finding that Dr. Reid violated COMAR 15.14.01.11, it is this ^{21 CHR}13 day of March, 2007, by the State Board of Veterinary Medical Examiners, **ORDERED**: That Dr. Reid is assessed a Civil Penalty in the amount of Three Hundred Dollars (\$300.00) and that she pay this penalty to the Board within thirty (30) days from the date of this Consent Agreement.
