# **CONSENT AGREEMENT**

This Consent Agreement, dated this Aday of Docember, 2005, is between the State Board of Veterinary Medical Examiners ("Board") and Patricia Lazik, D.V.M., License No. 4948. The Agreement concerns the charges that the Board filed against Dr. Lazik, pertaining to his treatment of "Gael," a female thirteen-year old Border Collie owned by Michelle Thompson.

Under State law, the Board is the licensing authority responsible for regulating the practice of veterinary medicine in this State, which includes filing disciplinary actions against veterinarians charged with violating the provisions of the Veterinary Practice Act and regulations adopted thereunder. The Board "may refuse, suspend, or revoke any application or license, and censure or place on probation any licensee ... if the veterinarian ... [f]ails to comply with [the Veterinary Practice Act and] Board rules and regulations after receiving a license" (Md. Code Ann., Agric. Art., §2-310(8)); and in lieu of, or in addition to, suspending a veterinarian's license, the Board may impose a civil penalty of not more than \$5,000 (Md. Code Ann., Agric. Art., §2-310.1).

In this matter, the Board filed one charge against Dr. Lazik alleging that the care she provided Gael fell below the minimal standard required of a veterinarian in this State, a violation of COMAR 15.14.01.07.

#### FINDINGS OF FACTS

Dr. Lazik, by entering into and signing this document, acknowledges that the Board has made the following Findings of Fact:

1. At all times relevant to the charges, Dr. Lazik was, and is, licensed to practice

veterinary medicine in the State of Maryland; and practiced veterinary medicine at the Veterinary Medical Center, located at 8942 Centreville Road, Easton, Maryland 21601.

- 2. On or about August 25, 2004, Ms. Michelle Thompson presented Gael, a female thirteen-year old Border Collie to Dr. Lazik for veterinary care (to wit: to examine a lump on the dog's left hind leg and to check the dog's ears for Scabies).
- 3. Dr. Lazik performed a biopsy of the lump for cytologic examination.
- 4. Dr. Lazik also took a skin scraping of the affected ear margins, which showed sarcoptic mange. To treat this condition, Dr. Lazik administered ivermectin subcutaneously at approximately 300 ug/kg body weight.
- 5. Approximately 24 hours later, Ms. Thompson indicated that Gael was very disoriented and appeared to be drunk, losing her balance when she attempted to stand, and had a prolapsed third eyelid clinical signs associated with ivermectin toxicity.
- 6. The amount of ivermectin administered to Gael (to wit: 300 ug/kg body weight) falls within a dosage range that has been widely reported to cause adverse effects in Collies, Collie-mixes, Shelties, Old English Sheepdogs, and other herding breeds -- which reports have appeared in commonly used, and readily available, veterinary textbooks and journals deemed as reliable authorities in the field of veterinary medicine (including Plumb's Veterinary Drug Handbook -- the textual authority Dr. Lazik cited).
- 7. Dr. Lazik should have known that the dose of ivermectin she administered to Gael could cause (and indeed, appears to have caused) the dog to suffer an adverse reaction, and for this reason, should have considered: (a) an alternative therapy with fewer side effects (e.g., amitraz); or (b) administering ivermectin more conservatively, that is, at a lower dose, and gradually increasing the dose while closely monitoring the patient for early detection of an adverse reaction.

## **CONCLUSIONS OF LAW**

On or about August 25, 2004, Dr. Lazik administered ivermectin to Gael, a Border Collie, at a dose that has been widely reported in recognized authorities to cause adverse effects in Collies, Collie-mixes, Shelties, Old English Sheepdogs, and other herding breeds (to wit: 300 ug/kg body weight). In administering ivermectin at this dose instead of considering: (a) an alternative therapy with fewer side effects (e.g., amitraz); or (b) administering ivermectin more conservatively, that is, at a lower dose, and gradually increasing the dose while closely monitoring the patient for early detection of an adverse reaction, Dr. Lazik's's care failed to conform to the minimal standards expected of a veterinarian in this State, a violation of COMAR 15.14.01.07.

#### <u>ORDER</u>

Based on the foregoing Findings of Fact and Conclusions of Law, finding that Dr. Lazik violated the Veterinary Practice Act, it is this day of <u>December</u>, 2005, by the State Board of Veterinary Medical Examiners, **ORDERED**:

- 1.) That Dr. Lazik shall pay is Civil Penalty in the amount of Three Hundred Dollars (\$300) within thirty (30) days from the date of this Consent Agreement;
- 2.) That Dr. Lazik shall pay Ms. Thompson Nine Hundred Twenty-Nine Dollars (\$929.00), which amount represents: a.) certain veterinary fees Ms. Thompson incurred stemming from Dr. Lazik's treatment of Gael, and b.) the cost to cremate Gael; and that Dr. Lazik shall pay this sum to Ms. Thompson within thirty (30) days from the date of this Consent Agreement.
